

Strategies for education and awareness campaigns

- Comprehensive public education and awareness building campaigns;
 - " should emphasize the rationale behind the programme and the benefits to the various stakeholders and the nation
 - " Should use both the print and electronic media
 - " Bill boards and flyers
 - ⁷ Dedicated websites
 - Should use both national and local languages
 - " Message should highlight benefits to stakeholders
 - ⁷ Consumers, distributors, manufacturers, national



Proposed actions for demonstration of efficient technologies of efficient on and off-grid lighting products

The use of traditional and opinion leaders in public for a to demonstrate benefits;

["]Demonstration in schools

- ["]Free distribution of subsidized CFL to carefully selected communities with incandescent retrieved for destruction
- "Implementation of financing schemes to cover the upfront cost of efficient lighting products
- Campaign to honour savers of energy (Save a watt campaign)
- "Implementation of social housing projects fully equipped with efficient lighting

Strategies to facilitate bulk procurement of efficient on and off-grid lighting products

Waiver of taxes and duties on the importation of the energy efficient lighting.

["]A policy to ensure that all lighting procured by government should be efficient ones



Efficient Lighting Toolkit: Summary of Lamps, MEPS, Labels & MVE

Key components of a narmonized "Mandatory labeling and certification for efficient lamps" for all ECOWAS countries

- A Test facility with standardized protocols,
- Minimum Efficiency Standards identical across the sub region
- " Label should have a common feature i.e. embossed with the ECOWAS emblem.
- Label should provide the same information such as lamp type, input power wattage,

manufacturer, luminous flux / efficacy and lamp life
